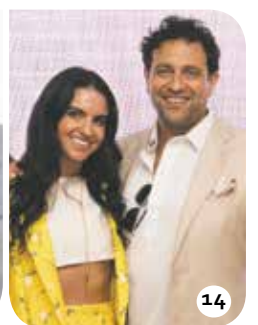
PowerList of The East End Celebrated

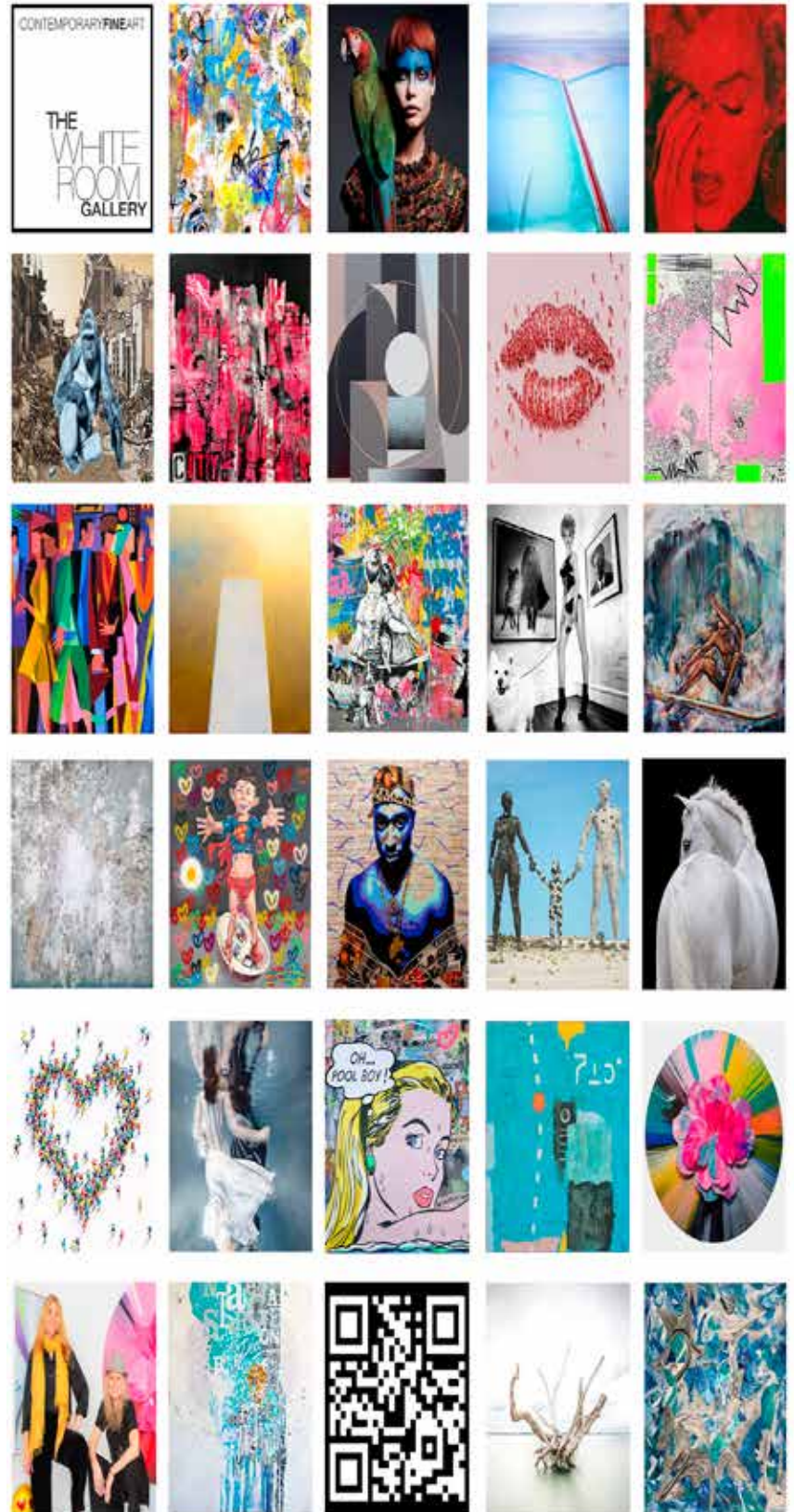
